

**Liana Bennett and Spokane Watercolor Society Agreement  
March 7, 2022**

This document dated March 7, 2022, between Liana Bennett (ARTIST) and Spokane Watercolor Society (SWS), is for the presentation of a workshop titled Abstracting - Composition and Design with Acrylics and Mixed Media, held on Friday and Saturday, September 23<sup>rd</sup> and 24<sup>th</sup>, 2022 and for jurying SWS's Fall Membership Show. Additionally, ARTIST agrees to participate in a live ZOOM meeting with SWS's membership to speak about the Fall Membership Show on Saturday, October 15, 2022.

SERVICES: ARTIST agrees to provide services in accordance with the following provisions:

1. In-person instruction, including demonstrations, shall occur on Friday and Saturday, September 23 and 24, 2022 from 10:00 am until 5 pm at Spokane Art Supply, 1303 North Monroe, Spokane, WA. Additionally, ARTIST will provide an assistant for the workshop at no cost to SWS. Also, ARTIST agrees to provide all participants the necessary supplies.
2. Online jurying for acceptance and in-person jurying for awards of SPONSOR's Fall Membership Show, Thursday, September 22, at Spokane Art School, 811 W Garland, Spokane, WA, at no cost to SWS.
3. In-person presentation of awards, Friday evening, September 23, at Spokane Art School during SWS's awards reception, at no cost to SWS.
4. Online participation via ZOOM in SWS's general membership meeting, October 15, to review the show using SWS's website gallery images of the participating pieces.
5. Enrollment in the workshop shall be not less than 10 nor more than 20.

PAYMENT: SWS agrees to pay ARTIST the following:

1. \$1,000 per day of instruction and \$20 per participant in the workshop.
2. Three nights of acceptable hotel stay in Spokane and \$40 per day for meals

ARTIST is an independent contractor and not an employee of SWS and, therefore, ARTIST shall be solely responsible for the payment of all taxes on compensation paid to ARTIST by SWS and will hold SWS harmless for any failure on the ARTIST's part to make such proper tax payment.


CANCELLATION: If a minimum of 10 students is not achieved two weeks prior to the workshop date of September 23, 2022, SWS reserves the right to cancel the workshop and pay ARTIST the sum of \$50.00 in liquidated damages.

INABILITY TO PERFORM: If ARTIST is unable to do the services outlined above, for any reason, SWS shall have no obligation to make any payments, but may attempt to reschedule ARTIST's appearance at a mutually acceptable date to complete the terms of the contract.

MODIFICATION: The Final Agreement conveys the full understanding between the parties hereto and may only be modified in a written agreement signed by both parties and is governed by the laws of the state of Washington.


